WAYS TO ENSURE ECONOMIC SECURITY OF ENTERPRISES

***Annotation.** This article presents the theoretical, legal and practical problems of ways to ensure the economic security of enterprises and analyzes their solutions. This article also provides recommendations on how to ensure the economic security of enterprises in the context of the COVID-19 pandemic.*

Keywords: security, economic security, economic security, legal and practical issues, COVID-19 pandemic, conceptual directions.

At the current stage of development, ensuring the economic security of industrial enterprises is an important task. Today's life itself demands the urgency of ensuring the economic security of enterprises. Modernization and intensive development of sectors of the economy, renewal of fixed assets, increasing the competitiveness of products based on modern technologies and strengthening the country's export potential, development of regional economies, overcoming social problems, foreign investment.

After all, the security of the economy serves as a basis for making decisions on socio-economic issues. Any change in the economic system is accompanied by the manifestation of various risks and threats. Theoretical problems related to the economic security of enterprises include: the economic literature does not disclose the role and importance of the security system, including economic security; the concept of economic security and its types have not yet been agreed among scientists of our country; lack of a scientifically based stratified system of economic security for the country, territory,

business entities, each person; insufficient substantiation of the principles of economic security of the enterprise; the main tasks of ensuring the economic security of enterprises are not sufficiently covered in the economic literature; lack of conceptual guidelines for ensuring the economic security of the enterprise; issues of economic security of the enterprise are not formed as a direction of science.

Legal problems of ensuring economic security of enterprises include: despite the fact that ensuring the economic security of enterprises is very important, the country has not yet developed a law «On Economic Security»; lack of a set of normative documents to ensure the economic security of the enterprise, based on the characteristics of each enterprise; the lack of an organizational and structural system to ensure the economic security of the enterprise.

Among the practical problems that need to be addressed to ensure the economic security of the enterprise in the context of the COVID-19 pandemic are: the lack of a system of indicators for assessing the economic security of enter-

prises; lack of internal security capabilities due to the lack of a system of factors affecting the economic security of the enterprise and the development of methods for calculating their impact; the costs of ensuring the economic security of the enterprise are not taken into account separately, as a result of which they are not given the opportunity to assess the effectiveness of the costs; problems such as the fact that the economic security service of the enterprise is not integrated into one system and the issues of their management are not fully resolved.

Given the role and importance of economic security in the system of these problems related to the economic security of industrial enterprises in the context of the COVID-19 pandemic, we have proposed new conceptual directions on how to ensure the economic security of industrial enterprises:

- Improving the security system of the enterprise and providing them with modern technical means;
- creation and continuous improvement of the system of protection of enterprise property (fixed assets, inventories, raw materials and supplies, semi-finished products, finished products, etc.);
- Improving the safety of enterprises in the transportation of property in accordance with modern requirements;
- Improving the information and scientific and technical security of enterprises;
- development and improvement of measures to ensure the safety of enterprise management and property owners;
- Improving the system of rapid reporting of theft and burglary to law enforcement agencies;
- introduction of the optimal mode of entry and exit to the enterprise;
